Welcome to AFOP's Children in the Fields Campaign annual Art & Essay contest for migrant and seasonal farmworker children in the United States. Below you will find the guidelines to the contest, and the application form.

2024 THEME: THE ECHOES OF THE HARVEST

ELIGIBILITY:

- Open to migrant or seasonal farmworker children in the United States of America
- Children must be between the ages of 10 to 18 years of age by July 15, 2024.

CONTEST DEADLINE: JULY 15, 2024

- Submit entries to AFOP by July 15, 2024.
- Late submissions will not be considered.
- If essay is handwritten, it must be legible. (Essays transcribe into computer are accepted)
- Art and Essay submissions must meet the size requirements or they will be disqualified.
- Submissions must be accompanied by:
 - 1. Original art and/or essay (art must include a brief description)
 - 2. 2024 Application Form
 - 3. Participant's photo
 - 4. Media Release Form

- Entries must clearly express this year's theme:
 The Echoes of the Harvest
- 2. Entries must be submitted by July 15, 2024.
- 3. Entries must be <u>original</u> and solely the work of the student.
- 4. Art and Essay Size: 8.5 x 11-inch paper (also known as letter size paper or photocopier paper)
- Art description and Essays can be submitted in English or Spanish
- 6. Must submit the 2024 Application Form, Media Release and one Photo
- 7. Incomplete submission disqualifies entry.

PRIZES:

- There will be 1st, 2nd and 3rd place prizes for each age category.
- Winners will be notified via telephone or by mail on August 30, 2024.
